ROUNDUP REVIEW



Cosworth #2523 sizzles SCCA Southeast Division! by Paul Csabon

Hello twin cammers, my name is Paul Csabon. While reading Twin Cam talk by Dale Malin in a Cosworth Vega magazine (3rd 97 issue) he mentioned a CV that is competing in SCCA ITA Road Racing in the Florida region. Well, since our team is running the only Cosworth in the southeast division I felt reasonably certain that Dale was referring to us, so I thought I'd take a little time to bring you folks up to date on our progress. In Florida we have two regions: Florida & Central Florida. The Florida region (my region of record) races at Moroso & Homestead, Central Florida races at Sebring long & short courses & Daytona's 24 hour course. The schedule starts in January with the 24 hours of Moroso & runs till November with the South Atlantic Road Race Championship series final. Last year we ran and finished 3rd in the entire Southeast Division. You can pull up any info on SCCA or it's regions (including race results) on the internet.

My personal experience with Road Racing began in 1970 when I purchased a 1965 Corvette coupe that we ran in SCCA B/P throughout the north east. After two years we "Graduated" to the old IMSA RS series and then on to IMSA's Firehawk driving a Firebird team car that won the championship in 1986 while still running the Vette in SCCA regional and national events. I have owned and driven GT1 and GTS1 cars in SCCA and IMSA including five Sebring 12 hour events and three Daytona 24 hour events for several successful teams.

In 1994 I saw an ad for a Cosworth ITA car that had originally been built for the old RS series (or so I've been told). The price was right and there was enough spares to last a few seasons, so with the costs and time commitment of GT1 I bought the CV and sold the GT1 Camaro so I could satisfy my racing addiction without having to sell my house! The winter of 1994 we disassembled the CV in preparation for the coming season (and after thinking GM had really lost it when they introduced the Vega) I was pleasantly surprised with the little car, especially the power plant.

Well after a lot of tweaking and a little tail chasing we wound up finishing that year in sixth place after 14 races with one DNF. To say that I was impressed is an understatement and so that year's off season consisted of a complete tear down of the entire chassis and drive train, everything was reprepped using all our pro racing experience while staying 100% within the rule book.

For the 1996 season we decided to run the entire southeast division. The car had now been developed to a level of consistency that rewarded us with no DNFs and 37 top ten finishes for a year ending 3rd place in the southeast division! 1997 finds us in even better shape with all top 5 finishes, two 1sts and no DNFs, we're currently 2 points out of 2nd and 14 out of 1st place in the championship standings. The Mazda, Toyota guys stopped laughing after the first year ended! At our last event we finished 1st in class and 11th overall beating 24 Mazdas, 6 Hondas, Toyotas, 5 240 -280Zs, 4 Mustangs, 2 Camaro's and 1 300ZX with a twenty two year old car!

Needless to say other drivers in our race group felt something might be amiss as far back as our first year.

5.0 Mustangs don't like being beaten by a VEGA!

To date we've been protested and torn down *nine* times and found legal each time. CV # 2523 has competed in the North Atlantic Road Racing, New York Road Racing Championship, Mid Atlantic Road Racing, South Atlantic Road Racing, Endurance Championship Racing and American Thundercar Racing se-

ries, we're hoping to capture that 1st place championship this year with two events remaining. (Editor's note: Paul missed the last two events of 1997 and the first half of 1998 due to family illness, the following is an update to above article)



We did manage a 3rd place points finnish at the 1997 seasons end without even going to the last two events! This year (1998) we ran our first event on July 18th & 19th, unfortunatly during Saturday mornings practice session there was an incident with a fatality that shut things down till after lunch time. We were so far behind schedule the stewards decided to eliminate all qualifying and grid all classes according to points. Well being our first race of the season we did'nt have any points and were grided 32nd overall and 18th in class. Saturdays races are only 8 laps, but we still managed to finnish 15th overall and 7th in class. We did'nt run on Sunday because when cranking up first thing in the morning the ring gear fell off the flywheel! Being the 2nd group out I decieded not to take a chance with a quick repair and have it come off again at 8200 rpm so I spent the rest of the day helping a friend sort out a new GT1 Corvette. I plan on running the rest of the FL regions races trying out some new ideas as long as there are no points at stake and start fresh in Janruary 1999.

1998 Robert A. Maloy Memorial Award Recipient Clark Kirby

The Robert A. Maloy Memorial Award, named after the founder of the Cosworth Vega Owners Association, is given out each year to a member of the CVOA who has demonstrated a dedication to the continuation of both the Cosworth Vega and the CVOA. First awarded after the death of Bob Maloy in 1992 by his wife Dani Maloy, it has become a CVOA tradition to present this award at the annual Round-up. This year's Robert A. Maloy Memorial Award was awarded to Clark Kirby in recognition for his many past years of service to the Cosworth Vega Owners Association. Clark was one of the founding member of the CVOA in 1979 and the first Region 12 director until he became vice president of membership, merchandise, and treasurer, positions he held for 6 years. During his tenure Clark presided over and contributed to the most significant growth period of the club, taking it to over 500 members. He also began the Cosworth Vega registry, keeping track of vital information on every car that came into contact with the club during hi tenure.

*Region 12 Director, 1979-1983.

*1983 Arlington TX Round-up 3 host.

*Vice President membership, merchandise, and treasurer, 1983-1989.

*Initiated Cosworth Vega Registry.

*Round-up attendance 1981 - 1991, 1993, 1995, 1996

*Implemented the concept that the CVOA should be owned by its members.

Most Notorious Accomplishments:

*Mexican Field Trials in a rented Chevette at 1983 Round-up.

*Displayed the Confederate flag from his hotel window at northern Roundups.

*Locked-up engine during autocross at the 91 Atlanta Round-up.

Clark, we thank you for your many contributions to the Cosworth Vega Owners Association and recognize the dedication and sacrifices you made, of both your time and personal resources, to the success of the club that we now enjoy. We struggle to fill the shoes you left.

The meeting was called to order by Dale Malin 8:16pm.

THE REPORTS:

*Annual Merchandise reports were presented by Tim Morgan. There have been good sales on the water pumps and heater kits. One weatherstrip kit left which has been claimed by John Cowall. Timing belts and stripe kits are going well (only 33 stripe kits are left in stock). Overall, sales have picked up over the last few months. John Cowall brought up that PCV valves with the correct AC/Delco number are available, but are listed under a different GM number. They may become available in the future. John will be checking on this. Joe Phillips made a motion to accept the Merchandising and Profit report. John Cowall has seconded the motion, motion passed.

*Financial report was presented by Mike Rupert . (The financial report is incorrect in the stated number of stripe kits sold by one. In addition, \$200 is still due from Tim Morgan to go towards the general membership.) Last year we increased the price of the stripe kits and are setting that money aside for funding future stripe kit purchases if possible. We finalized nonprofit status with the Dept. of Revenue in Pennsylvania. Received \$255 refund.

*General club expenses have gone

down, because we no longer pay income/corporate taxes. Magazine expenses are likely going up near 20% due to changes at Kinko's and 520 copies are being printed at this time versus 400 from a year ago. Laser printer was found at a good deal (approx \$500 savings), so it was purchased to save on Postscript proofs for Magazine work. Brad Stone made a motion to pass the Financial Statement. Steve Mayefsky 2nd, motion passed

- *Membership report was presented by Mike Rupert. With the growth of the Web people are finding out about CVOA. 289 paying members. 3 year renewals seem to be very popular and used by members. We are up 4.5% from last year. Bob Ralphs made the motion to accept the report and Brad Stone 2nd, motion passed
- * Kirby archive project is time intensive and is on hold until the last piece of old software is located and purchased .(We need an original copy of pfs:file, using a ProDos format on a 3.5 floppy.)
- *New window decals are done and are free for the weekend to members. After this they will be sold to members and given to new members in their registration kit.

OLD BUSINESS:

*Last year we voted on \$300 for a Hemmings ad was not acted on because we are getting excellent response from our web page on the Internet. Doug Perkins is still doing the Web page at this time.

NEW BUSINESS:

*Discussion on redefining or merging regions. No action recommended. Brad Stone addressed the issue on the insurance for the autocross, much discussion on this. . . which will be investigated and reported on by Dale Malin

Proposals for merchandise:

Proposal from Region 16 on piston co-op. . . More work needed to finalize. Club to support and advertise if enough interest is there. Insulation for hoods. Dan Newman will follow up on this project. Given contact on OEM of automotive insulation. Pulse tubes have not progressed. Need someone to work on this!

Roundup for 1999 in Las Vegas is in the process of being planned. Nancy Eszenszky has recommended that the Roundup be planned for June instead of July because of the weather. The final dates will be listed later.

Roundup 2000 needs a home. Steve Mayefsky will work with the Madison Sports Car Club if it is out there. It would probably be in Manitowac or Green Bay. Dale will contact some from the east coast to see if they wish to host the 2000 Roundup, if not it will go to Region 17, Steve Mayefske.

A new proposal for Concours Judging Rules has been submitted by Duke Williams Region 16. A committee of Duke Williams, Mike Rupert, Brad Stone, and Steve Mayefske will edit/finalize proposal for Director review. Target to have revised rules for 1999 Round-up. Discussed need for accounting of Round-Up expenses and passing on info from year to year to aid in planning. A Roundup Info Co-ordinator would be great idea if someone would volunteer! Any takers?

Doug Perkins (via Bob Chin) has said by the end of the year the web site will have color pictures of all the available Cosworths colors.

Election of Officials:

There are no new nominations sent in. John Cowall made motion to retain the current officials, Bob Chin 2nd this, passed unanimously.

Lori Malin made a motion to adjourn, Gabe Soto 2nd, motion passed.






Sonny & Dixie at the Bonneville Salt Flats



The hot rod above is none other than the ROSSI ROCKET, in its completed state. This *Vega powered* machine ran on 8-17-98. Sonny almost set a record at 132.084MPH, the current record is 132.895MPH. CAR COLLECTOR LEGISLATIVE ALFRI

As you may know, Speaker Newt Gingrich recently introduced The Economic Growth Act of 1998, H.R. 4125, which would reduce the maximum capital gains tax rate to fifteen percent for collectibles and collector cars held for at least one year. Recent government forecasts have project a tax surplus worth billions of dollars, making this an ideal year to reduce capital gains taxes.

Passing H.R. 4125 would:

- Reduce the capital gains tax rate on capital assets purchased after June 24, 1998 and held more than one year to a maximum of 15% for collectibles and collector cars, which were not covered by The Taxpayer Relief Act of 1997.
- Reduce the holding period for receiving the lower capital gains tax rate from 18 months to 12 months
- · Continue the trend of reducing disincentives in the tax code that relate to savings and investment

Tech Tip Testimonial

Snake oil, some people call it. But we instinctively want to believe the advertised claims. Oil additives are "mouse milk". Slick 50, STP, Wynn's Friction Proofing and a thousand others. Who among us hasn't been sorely tempted to try them?

Well, I'm here to tell you, "Amen, brothers and sisters. Yea and verily, I believe."

"In what?" you ask.

Well, it's Gunk Liquid Wrench. It really works. It's magic.

I bought a well rusted parts car last Fall, and it sported an intact set of pulse air tubes. They were in bad condition, of course, and I just knew from past experience that as soon as I tried to remove them from the header, the fitting and the tube would twist together, the rust bond between them would not shear, and the end of the tube would twist off. I would be left with junk. Now I know that heat is the enemy of rust, and that if two parts are seized by rust, simply heat them cherry red and they will come apart as if lubricated. But I hesitated to do this with these tubes. They looked awfully thin. So I decided to conduct an experiment.

I happened to see a spray can of Gunk Liquid Wrench on the shelf at the store, and so, since it was on sale, I said, "Why not?" I brought it home and sprayed the fittings at the header, making sure to pool the Liquid Wrench in the crevice between the fitting and the tubes. Then I left it sit. Every week or two or four, whenever I was in the barn and I thought of it, I'd spray again. I was in no hurry. About four months later Ken decided he'd like to swap the engine from this car into his #2584 for the '98 Roundup, and I said ok. He pulled the header off with the pulse air tubes still attached and set it carefully aside.

Then, a few days later I had some extra minutes and decided to see whether I could remove the fittings. To my utter amazement, the first seven turned immediately and easily! I needed only a small amount of force on the 9/16" line wrench to turn them.

Number eight was a different story entirely. I started to turn the fitting and immediately saw the tube begin to turn too. I stopped. I tried it again, gently, with the same result. I could see that rust had seized the fitting to the tube and that if I continued to twist the tube would shear. So I said to myself, "Self, you need some more Liquid Wrench."" I mounted the header in my vise so that the fitting was level. Then I filled the valley between the tube and the fitting with Liquid Wrench and let it soak for about 45 minutes. When I returned, the liquid had disappeared,

probably wicked away by capillary action. I tried the fitting again and saw the tube start to twist with it, so I stopped and again filled the crevice and let it soak. I filled and let it soak a third time before I tried again.

Lo and behold, the fitting now turned as easy as you please. Amen and hallelujah. I believe in magic and Liquid Wrench. I think I'll buy a deer whistle for my bumper!

Actual failure & Actual fix-Engine oil leak

After replacing three exhaust cam shaft seals and adding a shaft saver I still had an oil leak, at the exhaust cam gear.

Adding dye and using a high power black light I found oil seaping by one of the cam gear bolts. Removing the bolt and starting the engine produced oil spraying from the bolt holes. The cam had been drilled to deep in one hole, after cleaning the bolts and holes. I used blue Lock tight (242) on the bolts. Tightened the bolts and let them sit over night. No more oil leak. (Editor's note, I also experienced the same type of leak, on the *exhaust* cam as well. I wound up using an exhaust cam from another engine. I have also used RTV type sealers on bolt threads for the same type of leaks on Chrysler and some import camshafts.)


